### a. Wood Flood Plain and Site Plan

### Minutes:

Chairman Johnson opened the Public Hearing for FP 2024-12 and SP 2024-13 at 6:02 PM. Owner William Wood explained his plan to build a 20x30 building in the lot adjacent to his property on 415. This building would be used to mix concrete and provide outside storage for gravel. The applicant will use the existing driveway. The building will sit next to the existing shop, he would like it to set back from 415, to the right of his pond. The building will be located in the flood plain portion of the property. The applicant will work with Steuben County to get a BFE determination. Kyle Peterson asked about flood proofing. The building will be 2' higher than the existing shop, so there will no flood proofing. Chairman Johnson closed the public hearing at 6:27 PM A motion to approve the Flood Plain Permit 2024-12 with the condition that the secretary receive a certified Elevation Certificate before construction begins, was made by Laura Bowen and seconded by Denise Thompson.
